Parent Consent Form for International High School Summer Camp 2020

French American International School is monitoring the information provided by public health officials and government agencies about how to conduct summer camp in the midst of a pandemic, but much uncertainty about COVID-19 remains. Health and safety of our students is always the first priority.

The Athletic Department's Plan Includes:

- Pre-attendance education for coaches, staff and student-athletes.
- Health screening conducted by your unit before travel to our camp, including a temperature check, individual completion of COVID-19 Symptom Form, and hand sanitizing.
 - Note: should anyone in the unit not pass the arrival screening, the student will not be allowed to participate in activities.
- No person may attend camp if within the 14 days before the start of camp one or more of the following applies:
 - Such person exhibits symptoms of the Coronavirus, including but not limited to fever, chills, cough, trouble breathing, muscle pain, headache, sore throat, and/or new loss of taste or smell;
 - Such person has had close contact for a prolonged period of time with someone exhibiting symptoms of the Coronavirus;
 - Such person tests positive for the Coronavirus, has been diagnosed by a medical professional as having the Coronavirus, or is awaiting test results for the Coronavirus;
 - Such person is exposed to a confirmed outbreak of the Coronavirus or a person who has tested positive for the Coronavirus.
- Pods of no more than 12 will be permitted during each 3-week period.
- No shared equipment between students & Physical Distancing will always be observed.
- Extra handwashing /sanitizer stations throughout the vicinities.
- Dedicated staff to clean and disinfect high-touch surfaces and shared program equipment.

Although important, these efforts cannot eliminate the potential for exposure to COVID-19 or any other illness while participating in activities. Experts have said that people with COVID-19 may show no signs or symptoms of illness, but can still spread the virus, and people may be contagious before their symptoms occur. The fact is that someone with COVID-19 may pass the required health screenings and be allowed into camp.

We also know the very nature of athletics makes social distancing difficult in many situations. Information from the Centers for Disease Control and Prevention (CDC) states that older adults and people of any age who have severe underlying medical conditions, like heart or lung disease or diabetes, seem to be at higher risk for severe illness from COVID-19. If you are in one of these groups, please ensure you have approval from your health care provider before beginning athletic participation.

Parent/ Guardian Permission:

On behalf of my child(ren), any other parent or guardian for my child(ren), and myself, I hereby release, waive, discharge, covenant not to sue, and agree to hold harmless for any and all purposes International High School, French American International School, and each of their directors, staff members, coaches, or other organizations ("Releasees") associated with any International Athletics program or activity, from any and all liabilities, claims, demands, or injuries, including death, that may be sustained by my child(ren) because of his attendance at camp, or his participation in activities, at French American International School.

Without in any way limiting the foregoing, I expressly acknowledge that my release, waiver, discharge, covenant not to sue, and agreement to hold harmless includes negligence, as well as any and all claims whatsoever arising from or related to COVID-19. This agreement does not release or hold harmless Releasees from claims arising from their intentional misconduct or gross negligence. This Parent Consent Form is governed by the laws of the State of California.
